Participation and Structure

Participation in our Referral and Sales Program

Participation in our referral and sales program is only possible following a thorough application process and explicit approval by the Bros & Gains team. Anonymous participation is not allowed. Every potential participant must clearly identify themselves to the team.

The program is structured in three consecutive tiers, each offering increasing benefits:

- Rookie – Introduction and first steps in the program
- Partner – Active participant with expanded rights and bonuses
- Elite Partner – Top-level status with exclusive benefits and privileges
- PRESALE PHASE (Limited Special Conditions)



Rookie

Rookies are new or existing Bros & Gains members who hold BAGX tokens valued between \$0 and \$25,000.

Referral Compensation

Rookies earn 10% of the investment amount for each new client or investor they refer.

Requirements for Participation

Clients participating in our system via BAGX tokens must hold their tokens according to one of the following options:

- Vesting Program (12 months)
 - Tokens are locked in a team-defined 12-month vesting program.
 - In this case, referral commissions are paid immediately upon the client's participation.
- Manual 12-Month Holding
 - Clients hold their tokens independently for 12 months.
 - Referral commissions are paid evenly at the end of the 12-month period.
- Participation via Investment Companies
 - Referral commissions are paid after successful signing of the investment agreement and receipt of the investment funds.



Partner

Partners are existing Bros & Gains members who hold BAGX tokens valued between \$25,000 and \$49,999 and lock them, thereby removing them from public trading.

Referral Compensation

Partners earn 12.5% of the investment amount for each new client or investor they refer.

Requirements for Participation

Clients participating in our system via BAGX tokens must hold their tokens according to one of the following options:

1. Vesting Program (12 months)


- Tokens are locked in a team-defined 12-month vesting program.
- Referral commissions are paid immediately upon the client's participation.

2. Manual 12-Month Holding

- Clients hold their tokens independently for 12 months.
- Referral commissions are paid evenly over the 12-month period.

3. Participation via Investment Companies

- Referral commissions are paid after successful signing of the investment agreement and receipt of the investment funds.



Elite Partner

Elite Partners are existing Bros & Gains members who hold BAGX tokens valued at \$50,000 or more, lock them, and build their own commercial sales network.

Referral Compensation

Elite Partners earn 15% of the investment amount for each new client or investor they refer.

Requirements for Participation

Clients participating in our system via BAGX tokens must hold their tokens according to one of the following options:

- Vesting Program (12 months)
 - Tokens are locked in a team-defined 12-month vesting program.
 - Referral commissions are paid immediately upon the client's participation.
- Manual 12-Month Holding
 - Clients hold their tokens independently for 12 months.
 - Referral commissions are paid evenly over the 12-month period.
- Participation via Investment Companies
 - Referral commissions are paid after successful signing of the investment agreement and receipt of the investment funds.



Presale Phase

During the presale phase, special, time-limited conditions apply.

Compensation for referring new investors and members:

- 10% of the referred client's investment amount

Requirements for Participation

There are no specific requirements, holding periods, or payout restrictions.

- Vesting Program (0months)
 - All BAGX tokens will be promptly distributed to the referred client.
- Commission payouts are processed immediately upon successful receipt of funds.
